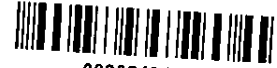


JUDICIAL SALE DEED

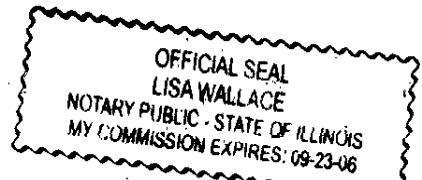
