If the Index is no longer available, the Note Holder will choose a new index that is based upon comparable information. The Note Holder will give me notice of this choice.

(C) Calculation of Changes

Before each Change Date, the Note Holder will calculate my new interest rate by adding **TWO AND TO IREE QUARTERS** percentage points (**2.750** %) to the Current Iraex. The Note Holder will then round the result of this addition to the nearest one-eighth of one percentage point (1.125%).
