2. MODIFICATION. For value received, Mortgagor and Lender agree to modify the Security Instrument as provided for in this Modification.

The Security Instrument is modified as follows:

- A. Secured Debt. The secured debt provision of the Security Instrument is modified to read:
 - (1) Secured Debts. This Security Instrument will secure the following Secured Debts:
 - (a) Specific Debts. The following debts and all extensions, renewals, refinancings, modifications and replacements. A promissory note, No. 6037479-03, dated August 3, 2001, from Daniel Kravetz and Lakeside Bank, as trustee, under Trust Agreement dated April 4, 2001 and known as Trust No. 10-2265 (Borrower) to Lender, with a loan amount of \$364,077.88 with an interest rate of 6.0 percent per year and maturing on February 18, 2008.
 - (b) All Debts. All present and future debts from Daniel Kravetz and Lakeside Bank, as trustee, under Trust Agreement dated April 4, 2001 and known as Trust No. 10-2265 to Lender, even if this Security Instrument is not specifically referenced, or if the future debt is unrelated to or of a different type then this debt. If more than one person signs this Security Instrument, each agrees that it will secure doors incurred either individually or with others who may not sign this Security Instrument. Nothing in this Security Instrument constitutes a commitment to make additional or future loans or advances. Any such commitment must be in writing. In the event that Lender fails to provide any required notice of the right of rescission, Lender waives any subsequent security interest in the Mortgagor's principal dwelling that is created by this Security Instrument. This Security Instrument will not secure any debt for which a non-possessory, non-purchase money security interest is created in "household goors" in connection with a "consumer loan," as those terms are defined by federal law governing unfair and deceptive credit practices. This Security Instrument will not secure any debt for which a security interest is created in "margin stock" and Lender does not obtain a "statement of purpose," as defined and required by federal law governing securities.
 - (c) Sums Advanced. All sums advanced and expenses incurred by Lender under the terms of this Security Instrument.
- 3. CONTINUATION OF TERMS. Except as specifically amended in this Modification, all of the terms of the Security Instrument shall remain in full force and effect.
