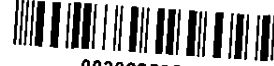

Payments on the Note are to be made in accordance with the following payment schedule: 84 monthly consecutive principal and interest payments in the initial amount of \$2,216.68 each, beginning April 1, 2003, with interest calculated on the unpaid principal balances at an initial interest rate of 6.125% per annum; and 216 monthly consecutive principal and interest payments in the initial amount of \$2,216.68 each, beginning April 1, 2010, with interest calculated on the unpaid principal balances at an interest rate based on the weekly average yield on U.S. Securities adjusted to a constant maturity of One (1) year, as made available by the Federal Reserve Statistical Release H.15(519) (currently 1.290%), plus a margin of 3.000%, resulting in an initial interest rate of 6.125%. Grantor's final payment will be due on March 1, 2028 and will be for all principal and accrued interest not yet paid, together with any other unpaid amounts under this Assignment. If the index increases, the payments tied to the index, and therefore the total amount secured hereunder, will increase. Any variable interest rate tied to the index shall be calculated as of, and shall begin on, the commencement date indicated for the applicable payment stream. Notwithstanding the foregoing, the variable interest rate or rates provided for in this Assignment shall be subject to the following minimum and maximum rates. 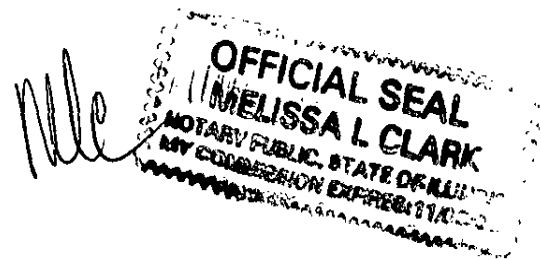
