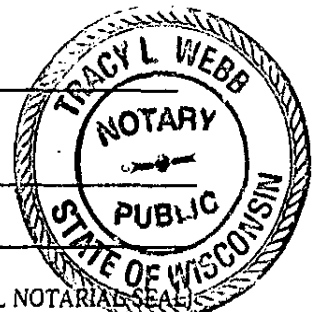

EXHIBIT "A"LEGAL DESCRIPTION

Parcel 1: That part of Lot 5 lying North of a line drawn at right angles to the East line of Lot 5 from a point on said East line of Lot 5, which point is 125.20 feet Northerly of the Southeast corner of Lot 5, (except the North 20 feet thereof, as measured along West line of Lot 5, the South line of said 20 feet tract being a curved line drawn parallel with North line of Lot 5 and (except that part thereof described as follows: Beginning at a point of intersection of the West line of Lot 5 with a line drawn at right angles to the East line of Lot 5 from a point on said East line of Lot 5, which point is 125.20 feet Northerly of the Southeast corner of Lot 5; thence Northerly along said West line of Lot 5 to a point 20 feet Southerly of the Northwest corner of said Lot 5; thence Easterly along a curved line drawn parallel with North line of Lot 5 to a point on a line 7 feet East of (as measured along North line of Lot 5 and parallel with West line of Lot 5; thence Southwesterly along a straight line 52.62 feet more or less to the point of beginning);

Parcel 2: The North 20 feet of Lot 5, as measured along West line of Lot 5; the South line of said tract being a curved line drawn parallel with the North line of Lot 5 (except the West 37 feet thereof, as measured along North line of Lot 5; the West line of said tract drawn parallel with West line of Lot 5;

all in Golf-Mill Subdivision of part of the East 1/2 of Section 14, Township 41 North, Range 12, East of the Third Principal Meridian, according to Plat thereof registered in the Office of the Registrar of Titles of Cook County, Illinois, on August 4, 1960 as Document Number 1935472, in Cook County, Illinois.
