This Power of Attorney shall remain in full force and effect until revoked by me, or until January 31, 2003, whichever event shall first occur, provided further that any such revocation shall be of no effect in respect to parties acting or things done in reliance herein prior to the actual receipt by such parties of written notice of said revocation.
