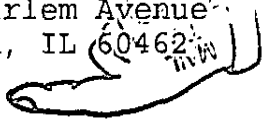

AFFIDAVIT OF HEIRSHIP

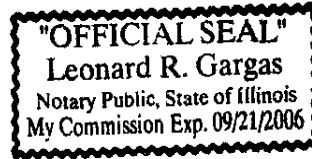
