Limited Power of Attorney To Prepare & Execute Lien Release Instruments

ILLINOIS SMALL BUSINESS GROWTH CORPORATION is a Certified Development Company ("CDC"), a non-profit corporation certified by the United States Small Business Administration ("SBA") to participate in the SBA loan program designed to help small businesses finance the purchase or construction of a long-term fixed asset ("Asset") such as real estate, buildings, and equipment (the "504 Program").


