FIFTH AND FINAL AMENDMENT TO THE DECLARATION ESTABLISHING A PLAN FOR CONDOMINIUM OWNERSHIP FOR "SUNCHASE POINTE CONDOMINIUMS" CITY OF OAK FOREST, COOK COUNTY, ILLINOIS

THIS FIFTH AMENDMENT, made and entered into by First Midwest Bank, successor to First Midwest Trust Company, not individually, but as Truslee under Trust Agreement dated March 20, 1998 and known as Trust No. 98-6340, for convenience hereina(te) referred to as the "Declarant":

WITNESS THAT:

WHEREAS, by the Declaration of Condominium Ownership and By-Laws, Easements, Restrictions and Covenants for "SUNCHASE POINTE CONDOMINIUMS" (f.erginafter referred to as "Declaration"), recorded in the office of the Recorder of Deeds of Cook County, Illinois, or, June 7, 2001 as Document No. 0010493842; Certificate of Correction recorded in the Office of the Recorde, or Deeds of Cook County, Illinois, on July 11, 2001 as Document No. 0010612435; First Amendment recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on July 11, 2001 as Document No. 0010612436; Second Amendment recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on November 7, 2001 as Document No. 0011046137; Third Amendment recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on March 19, 2002 as Document No. 0020307247; and Fourth Amendment recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on September 10, 2002 as Document No. 0020993158, submitted certain real estate to the Condominium Property Act of the State of Illinois (the "Act"), said Condominium being known as "SUNCHASE POINTE CONDOMINIUMS" (the "Condominium"); and

WHEREAS, under the Declaration the right is reserved in the Developer to annex are add certain real property to the property described in the Declaration and thereby add to the Property subject to the Condominium, and the Declaration; and

WHEREAS, Article XVI of the Declaration is the Developer's authority, coupled with the provisions (765 ILCS 605/25) of the Act, to add on and annex to the Property (as defined in the Declaration) a portion or portions of the Development Parcel described in Exhibit "D" to the Declaration;

WHEREAS, the Declarant, as the legal titleholder of the parcel submitted to the Condominium under this Fifth Amendment, hereby amends said Declaration pursuant to the provisions hereof.

NOW THEREFORE, said Declarant, legal owner of the parcel of real property in Cook County, Illinois, legally described on the plat of survey attached hereto as EXHIBIT "A", submits said parcel of real property to the provisions of the Condominium Property Act of the State of Illinois and to the provisions of the aforesaid Declaration and hereby makes this Declaration (hereinafter referred to as Fifth Amendment to the Declaration) as to divisions, covenants, restrictions, limitations, conditions, and uses to which the said real property and improvements thereon may be put hereby specifying that the Fifth Amendment to the Declaration shall constitute covenants to run with the land and shall be binding on said Declarant, its successors and assigns, and all subsequent owners of all or any part of said real property and improvements, together with their grantees, successors, heirs, executors, administrators, devisees or assigns:

- Declarant, hereby adopts by reference and submits the said parcel to the Declaration of Condominium Ownership and By-Laws, Easements, Restrictions and Covenants for "SUNCHASE POINTE CONDOMINIUMS" recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on June 7, 2001 as Document No. 0010493842; Certificate of Correction recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on July 11, 2001 as Document No. 0010612435; First Amendment recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on July 11, 2001 as Document No. 0010612436; Second Amendment recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on November 7, 2001 as Document No. 0011046137; Third Amendment recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on March 19, 2002 as Document No. 0020307247; and Fourth Amendment recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on September 10, 2002 as Document No. 0020993158, and makes said documents a part hereof, 25 if set forth herein at length.
- 2. Developer pursuant to its rights, power and authority as provided in the Condominium Property Act of the State of Illinois and the said Declaration, and the Declarant as fee owner of the parcel described on the Fifth Amended Exhibit "D", adds on and annexes to the now existing Property, defined as set forth in the said Declaration, the additional Property with improvements legally described on the Fifth Amended Exhibit "D", said added Property being a part of the Development Parcel set forth in Exhibit "D" of the Declaration.
- Developer, pursuant to the provisions of the said Declaration, hereby amends Exhibit "A" to said Declaration by adding to it a plat of survey setting forth the legal description of the parcel, its surveyed boundaries and the location within the parcel of the units soing submitted to the Condominium Act by this Fifth Amendment. Upon the recording of this Fifth Amendment to the Declaration, the Property shall consist of the parcel described on Exhibit "A" to the Declaration and the parcel described on the Fifth Amended Exhibit "A" attached hereto.
- 4. Declarant, pursuant to the provisions of said Declaration, hereby amends Exhibit "B" to said Declaration by substituting therefor the Fifth Amended Exhibit "B" attached pareto.
- 5. Declarant, pursuant to the provisions of said Declaration, hereby amends Exhibit "C" to said Declaration by substituting therefor the Fifth Amended Exhibit "C" attached hereto.
