The tenant of Unit 3 has waived or has failed to exercise the right of first refusal

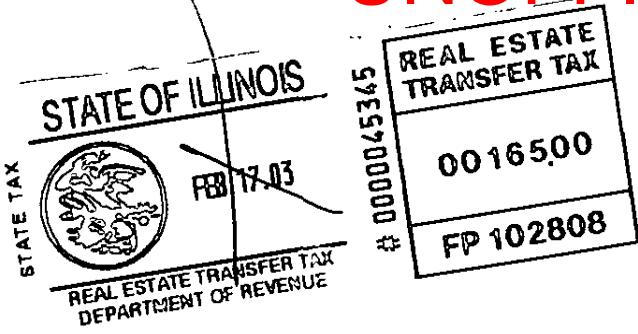

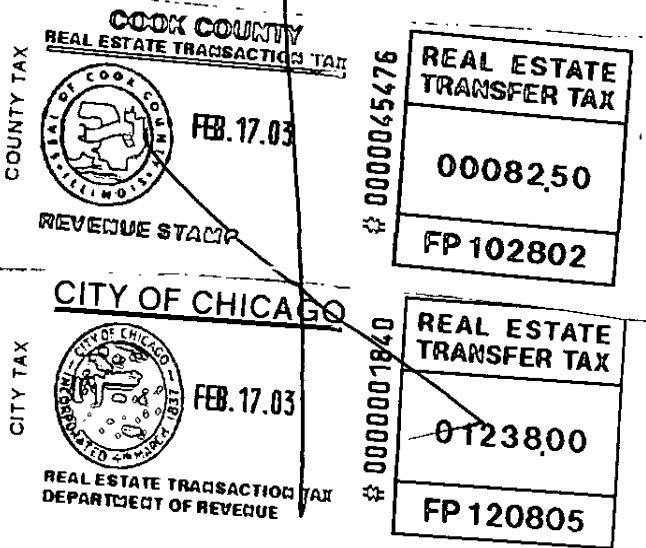
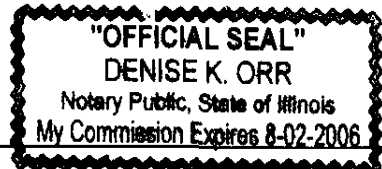
