**7. 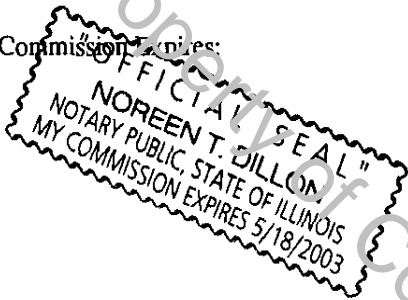
