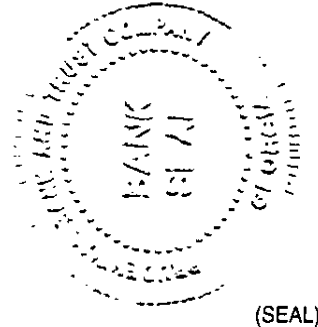
DISCHARGE OF MORTGAGE

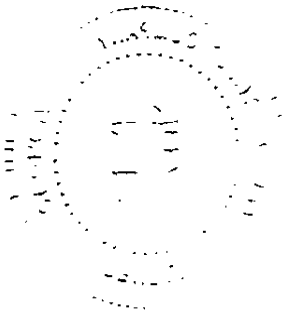
