MODIFICATION OF MORTGAGE

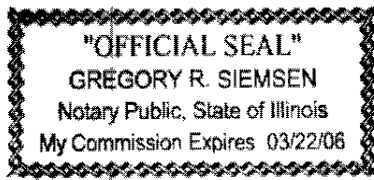

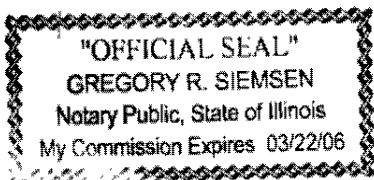
