

- 3. MAXIMUM OBLIGATION LIMIT. The total principal amount secured by this Security Instrument at any one time shall not exceed \$ 43,700.00

 This limitation of amount does not include interest, attorney fees, and other fees and charges validly made pursuant to this Security Instrument. - 6. PRIOR SECURITY INTERESTS. With regard to any other mortgage, deed of trust, security agreement or other lien document that created a prior security interest or encumbrance on the Property, Mortgagor agrees:

- F. Lender's Prior Consent. A good faith helief by Lender that Lender at any time is insecure with respect to any person or entity obligated on the Secured Debt or that the prospect of any payment or the value of the Property is impaired shall also constitute an event of default.
- 15. REMEDIES ON DEFAULT. In so ne instances, federal and state law will require Lender to provide Mortgagor with notice of the right to core or other notices and may establish time schedules for foreclosure actions. 18. ENVIRONMENTAL LAWS AND HAZARDOUS SUBSTANCES.
