SUBORDINATION AGREEMENT



THIS SUBORDINATION AGREEMENT, made in the City of Columbus, State of Ohio, as of the 27th day of January, 2003, by Bank One, N.A. a national banking association organized and existing under and by virtue of the laws of the United States of America, and doing business and having its principal office in the City of Columbus, County of Franklin, and State of Ohio ("Bank").

WITNESSETH

WHEREAS, the Bank is the owner of a mortgage dated August 30, 1995 and recorded September 8, 1995 among the land records in the Office of the Recorder of Deeds of Cook County, Illinois as Document Number 95599866 made by LaSalle National Bank, as Trustee, under Trust Agreement dated May 5, 1981 and known as Trust No. 103956 (collectively, "Grantor"), to secure an indebtedness of \$ 50,000.00 ("Mortgage"), and

WHEREAS, Grantor is the owner of that certain parcel of real estate commonly known as 520 Warwick Road Kenilworth, IL 60043 and more specifically described as follows:

WHEREAS, Wells Fargo Home Mortgage, its successors &/or assigns ("Mortgagee") has refused to make a loan to Terry J. Booth and Carol W. Booth (collectively, "Borrower") of \$451,000.00 except upon condition that the Mortgage be subordinate to said mortgage lien of Mortgagee.

NOW, THEREFORE, in consideration of the sum of Ten (\$10.00) Dollars in hand paid by each of the parties hereto to the other, and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and in order to induce Mortgagee to make the loan to Borrower, it is hereby mutually agreed, as follows:

- I. That the Bank covenants and consents that the lien of its Mortgage shall be subject and subordinate to the lien of Mortgagee's mortgage dated _____ reflecting and securing the loan made by Mortgagee to Borrower, in the amount of \$451,000.00 plus interest as charged according to the terms of the Mortgage note, and to all renewals, extensions or replacements of said mortgage; and
- II. That this Agreement shall be binding upon and shall inure to the benefit of Mortgagee, its successors and assigns.
