If each Periodic Payment is applied as of its scheduled due date, then Lender need not pay interest on unapplied funds. Lender may hold such unapplied funds until Borrower makes payment to bring the Loan current. If Borrower does not do so within a reasonable period of time, Lender shall either apply such funds or return them to Borrower. If not applied earlier, such funds will be applied to the outstanding principal balance under the Note immediately prior to foreclosure. 2. Application of Payments or Proceeds. What Lender requires pursuant to the preceding sentences can change during the term of the Lou. The insurance carrier providing the insurance shall be chosen by Borrower subject to Lender's right to disapprove porrower's choice, which right shall not be exercised unreasonably.
