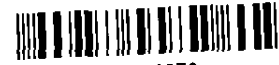

**SUBORDINATION OF LIEN**

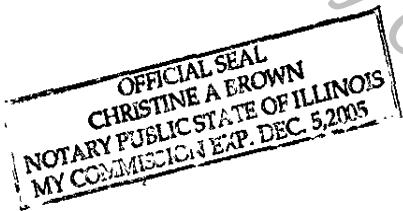
