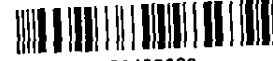

SPECIFIC AND LIMITED POWER OF ATTORNEY


