and commonly known as 600 Academy Court, Schaumburg, Illinois 60194.





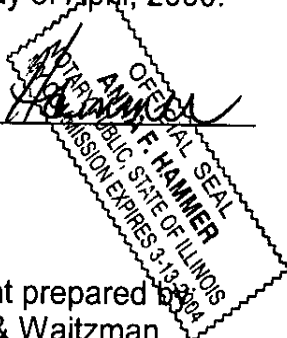
