MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE, made this 27th day of March, 2000, between THE LURIE COMPANY, a California corporation having an address at 120 South LaSalle Street, Chicago, Illinois 60603 ("Landlord"), and PROXICOM, INC., a Delaware corporation having an address at 11600 Sunrise Valley Drive, Reston, Virginia 20191 ("Tenant").

WITNESSETH THAT:

Fursuant to a certain lease agreement between Landlord and Tenant dated March 27, 2000 (the 'Lease"), Landlord for and in consideration of One (\$1.00) Dollar and other good and valuable consideration has demised and leased to Tenant 26,104 Rentable Square Feet (as defined in the Lease) or the twenty first (21st) floor; 26,510 Rentable Square Feet on the twenty second (22nd) Floor, and 15.300 Rentable Square Feet on the twenty third (23rd) floor consisting of a total of 68,914 Rentable Square Feet of space in the building (the "Building") known as 120 South LaSalle Street, located or that certain lot, piece or parcel of land in the City of Chicago, County of Cook, and State of Illin is, which land is described in Exhibit "A" attached hereto and by this reference made a part hereot.

TO HAVE AND TO HOLD the same for a term of eleven (11) years and six (6) months beginning October 1, 2000 and end ng March 31, 2012 unless sooner terminated or further extended as provided in the Lease.

Subject to the terms and provisions of the Lease, Tenant shall have the right and option to extend the term of the Lease for a period not to exceed five (5) years from the expiration of the term thereof.

Subject to the terms and provisions of the Lease, Tenant shall have expansion options with regard to leasing (i) 10,936 Rentable Square Feet on the eighteenth (18th) floor of the Building, and (ii) 14,678 Rentable Square Feet on the eighteenth (18th) floor of the Building.

Subject to the terms and provisions of the Lease, Tenant shall have the continuous Right of First Offer (as defined in the Lease) to lease space on the sixteenth (16th) through the twentieth (20th) floors of the Building which becomes vacant and available for leasing Juring the term of the Lease.

This Memorandum of Lease is intended to provide constructive notice of the existence and terms of the Lease, and in no way modifies or amends the Lease. If any provisions of this Memorandum of Lease conflict with those of the Lease, the Lease terms shall prevail.
