(the "Lender")

of the same date and covering the Property described in the Security Instrument and located at:

The Property includes, but is not limited to, a part 1 of land improved with a dwelling, together with other such parcels and certain common areas and facilities, as described in Declaration of Covenants, Conditions, and Restrictions of Record (the "Declaration"). The Property is a part of a planned unit development known as

[Name of Planned Unit Development]

(the "PUD"). The Property also includes Borrower's interest in the homeowners association or equivalent entity owning or managing the common areas and facilities of the PUD (the "Cwners Association") and the uses, benefits and proceeds of Borrower's interest.

provides insurance coverage in the amounts, for the periods, and against the hazards Lender requires, including fire and hazards included within the term "extended coverage," then:

- (i) Lender waives the provision in Uniform Covenant 2 for the monthly payment to Lender of the yearly premiur, installments for hazard insurance on the Property; and
- (ii) Ecrrower's obligation under Uniform Covenant 5 to maintain hazard insurance coverage on the Property is decined satisfied to the extent that the required coverage is provided by the Owners Association policy.
