CAMENO REAL UNIT II, A SUBDIVISION IN THE
NORTHWEST 1/4 OF SECTION 16, TOWNSHIP 36 NORTH,
RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN IN
COOK COUNTY, ILLINOIS.

WHEREAS, said DECLARATION was recorded as document number 21 482 361;

WHEREAS, said DECLARATION created a common interest community with the right
to levy assessments and special assessments against owners of units located within the above
described real estate, and the DECLARATION provides for liens and rights of the Association to
collect unpaid and/or delinquent assessments and other restrictions.

WHEREAS, since the DECLARATION was recorded in approximately 1971, the
Association Board of Managers wanted a Memorandum recorded clearly identifying the
Association and obligations of the owners, including but not limited to the need for paid
assessment letters at the time of property sale.


NOW THEREFORE, THIS MEMORANDUM IS RECORDED as additional notice to
