If the amounts held by Lender for Escrow Items exceed the amounts permitted to be held by RESPA, Lender shall account to Borrower for the excess funds as required by RESPA. Lender's obligation to return any excess payment with interest on demand is stated in a timely notice, or (iii) request that any excess payment, with interest thereon at the Note rate, be excess payment, with interest thereon at the Note rate (a rate equal to the interest rate which would have been stated in a timely notice, when Borrower has the option to either (i) demand the return to Borrower of any and Borrower made any monthly payment exceeding the payment which should have been accordance with paragraph (E) of this Rider decreased, but Lender failed to give timely notice of the decrease less than 25 days after Lender has given the required notice. If the monthly payment calculated in accordance with paragraph (E) of this Rider for any amount calculated in the month preceding the first payment date which occurs at least 25 days after Lender has given Borrower the notice of changes required by paragraph (F) of this Rider, Borrower shall have no obligation to pay any increase in the monthly first payment date which occurs at least 25 days after Lender has given Borrower the notice of changes effective on the Change Date. Borrower shall make a payment in the new monthly amount beginning on the first payment date which occurs at least 25 days before the new monthly payment amount is due, and must set forth a new interest rate calculated in accordance with paragraphs (C) and (D) of this Rider will become effective on the Change Date.

## (G) Effective Date of Changes

The notice must be given at least 25 days before the new monthly payment amount is due, and must set forth Lender will give notice to Borrower of any change in the interest rate and monthly payment amount to the same to the new monthly payment amount, and (viii) any other information which may be required by law from the change in monthly payment amount, and (vii) any other information which may be required by law from monthly payment amount, (vi) the Current Index and use of it was published, (viii) the method of calculating (i) the date of the notice, (ii) the Change Date, (iii) the old interest rate, (iv) the new interest rate, (v) the new monthly payment amount to the new monthly payment of principal and interest.

## (F) Notice of Changes

If the new interest rate changes on a Change Date, Lender will calculate the amount of monthly payment of principal and interest which would be necessary to repay the unpaid principal balance in full at the Maturity Date at the new interest rate which would be owed on the Change Date if there had been no default in use the unpaid principal balance which substantially equals payments. In making such calculation, Lender will paymen on the Note, reduced by the amount of any prepayments to principal. The result of this calculation will be the amount of the new monthly payment of principal and interest.

## (E) Calculation of Payment Change

The existing interest rate will never increase by more than one percentage point (1.0%) on any single Change Date. The interest rate will never be more than five percentage points (5.0%) higher or lower than the initial interest rate, as stated in Paragraph 2 of the Note.

## (D) Limits on Interest Rate Changes

Before each Change Date, Lender will calculate a new interest rate by adding a margin of 2.750 percentage points (0.125%). Subject to the limits stated in Paragraph (D) of this Rider, this rounded amount will be the new interest rate until the next Change Date.
