"My name is Thomas J. Keenan. I am over the age of 21. I have been employed as the Sr. Vice President of Huntsman Chemical Corporation ("Huntsman") since October 1, 1994. Since its purchase from Amoco Chemical Company on December 6, 1996, I have personal knowledge of Huntsman's ownership and use of the property located at 8400 Willow Springs Road, in the Village of Willow Springs, Cook County, Illinois (the "Property"), which is more particularly described on Exhibit "A" attached hereto. At the time of Huntsman's purchase of the Property a driveway existed between that portion of the Property identified as Parcel 2 and the access easement identified as Parcel 3 on Exhibit "A." During the time that Huntsman has owned the Property, this driveway has been used to provide access to Wentworth Road over and along Parcel 3. This use has been continuous, open and notorious, and without the permission of the fee owners of Parcel 3. To the best of my knowledge, the drivey'zy has been in existence and has been openly and notoriously used to provide access to Wentworth Road from Parcel 2 for more than 20 years.
