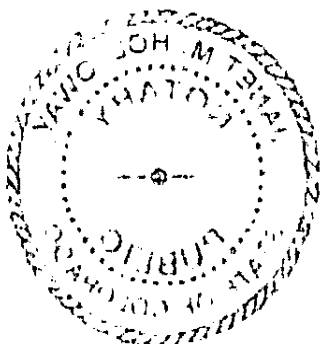


Dear Sir / Madam:
