- 2. The parties were residents of the State of Illinois at the time the Petition for Dissolution of Marriage was commenced and have maintained the same in the State of Illinois for more than ninety (90) days prior to the date of the hearing herein.
- 3. The parties were lawfuly married on July 20, 1972 in Chicago, Cook County, Illinois and said marriage is registered therein.
- 4. No children were born to the parties as a result of said marriage. No children were adopted by the parties and the Respondent is not now pregnant by the Petitioner.
- 5.
