It is further ordered that defendant(s) his/her/their agents, successors, heirs or assigns maintain the vacant premises boarded and secured until further order of court. The court reserves jurisdiction of this matter for the purposes of modification, enforcement or termination of this permanent injunction.

3. This order is final and appealable, the court finding no just cause or reason to delay its enforcement or appeal.
