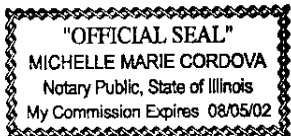

This deed is subject to:

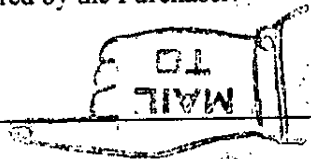

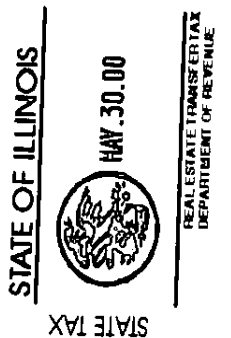
