AN ORDINANCE ANNEXING THE PARK DISTRICT OF DAK FOREST, CODK COUNTY, ILLINDIS, PROPERTY WITHIN THE CITY OF DAK FOREST NOT PREVIOUSLY IN SAID PARK DISTRICT, WHICH PROPERTY IS DESCRIBED IN THIS ORDINANCE AND LIES WHOLLY WITHIN THE COUNTY OF COOK AND STATE OF ILLINDIS

WHEREAS, Section 3-10 of Chaper 105 of the Illinois Revised Statues of 1965 provides that a Park District may sames by Ordinance all that territory within a City or Village in which said Park District operates: and

WEREAS, the Commissioners of the Uak Forest Park District, Cook County, Illinois, have considered the question of the Annexation of the territory hereinafter described and have determined that said territory is within the City of Uak Forest, Cook County, Illinois, and is contiguous to the territory of the Oak Forest Park District of Cook County, Illinois, and that the residents thereof currently use the facilities of saic Park District and will in the future use and need additional facilities in such areas for recreation and park purposes: and

WHEREAS, it is to the best interests of all of the residents of said Park Mistrict and to be in the best interests of the resident, the voters and owners of the territory hereinafter described to become a part of the Clak Forest Park District.

NOW THEREFORE, BE IT URDAINED BY THE COMMISSIONERS OF THE OAK FOREST PARK DISTRICT:

Section 1. That the territory hereinafter described, said territory described in this Ordinance, and specifically by reference made a part hereof, which said territory being contiguous to the territory of the Oak Forest Park District of Cook County, Illinois, and not within and Park District, or any other Park District, and within the provisions of said Chapter 105, Section 3-10 of the Illinois Revised Statues of 1965 be and the same is hereby annexed to the Oak Forest Park District, Cook County, Illinois, in accordance with the provisions of said Chapter 105, Section 3-10 of the Revised Statutes of Illinois. The territory hereby annexed, as shown by the shaded areas on the maps hereto attached, which are made a part of this Ordinance, is known and described as follows to wit:

LOT 2 IN BLOCK 2 (EXCEPT THAT PART LYING SOUTHEASTERLY OF A LINE 175 FEET NORTHWESTERLY OF AND PARALLEL WITH THE INDIAN BOUNDARY LINE) IN CHERRY HILL RANCHETTES IN THE SOUTH FRACTION OF THE NORTHEAST 1/4 SOUTH OF THE INDIAN BOUNDARY LINE OF SECTION 22 AND THE SOUTHEAST FRACTIONAL 1/4 NORTH OF THE INDIAN BOUNDARY LINE OF SAID SECTION 22, TOWNSHIP 36 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COURT COUNTY, ILLINDIS

and which said tract of land above described and in the attached description is intended to be all in the territory within the City Limits of the City of Uak Forest not previously included within the Uak Forest Park District.
