costs, charges and expenses relating to weed removal

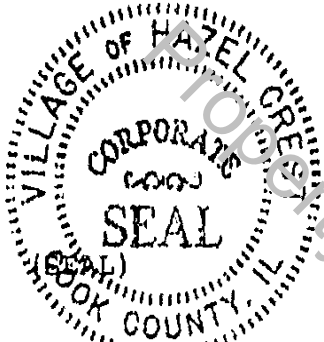
to the above-described property, the receipt of such payment being hereby acknowledged, does hereby release and discharge the above-described property from the lien created.
