AN ORDINANCE ANNEXING CERTAIN PROPERTY TO THE VILLAGE OF PALATINE SOUTHWEST CORNER OF CRESCENT AVENUE AND ELLIS STREET

WHEREAS, the Owners of record of the following described territory have petitioned that said territory be annexed to the Village of Palatine, Illinois; and

WHEREAS, the Municipal Authorities find and have determined that said territory is contiguous to the Village of Palatine; and

WHEREAS, the Palatine Rural Fire Protection District has been duly notified in writing more than ten (10) days in advance of consideration of this ordinance, pursuant to statutes;

NOW, THEREFORE, BE IT CROAINED, by the President and Board of Trustees of the Village of Falatine, acting in the exercise of their home rule power:

SECTION 1: That the following territory:

Lot 1, Block 15 in Arthur T. McTrosh & Company's Palatine Hills, being a Subdivision of part of the East half of the Northeast Quarter of Section 21, Township 42 North, Range 10, East of the Third Principal Meridian, recorded February 15, 1928 as Document No. 392915 in Cook Covity, Illinois

Also that portion of unincorporated right of way of Ellis Street lying adjacent to the above described parcel.

Commonly known as the Southwest corner of Crescent Avenue and Ellis Street

and as shown on the plat of annexation attached hereto and made a part of this ordinance, be and the same is hereby annexed to the Village of Palatine.

SECTION 2: That upon passage of this ordinance, a copy hereof, including the plat as certified as correct by the Village Clerk, be filed with the Recorder of Deeds of Cook County, Illinois in accordance with 65 ILCS 5/7-1-1, et. seq.

SECTION 3: That all ordinances or parts of ordinances in conflict with this ordinance be and the same are hereby repealed.
