MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE, dated as of NOVEMBER 30, 1993, by and between LASALLE NATIONAL TRUST NA not individually but as Successor Trustee under Trust Agreement dated September 30, 1980 and known as Trust No. 103192 (hereinafter called "Landlord"), and CITIBANK, FEDERAL SAVINGS BANK (hereinafter called "Tenant"):

The Lease grants to Tenant options to extend the term thereof from the date upon which it would otherwise expire for two (2) separate successive additional periods of five (5) years each upon and subject to the terms and conditions stated in the Lease.

It is further understood and agreed that said Trustee has no agents or employees and merely holds naked legal title to the property herein described; that said Trustee has no control over, and under this LEASE assumes no responsibility for (1) the management or control of such property, (2) the upkeep, inspection, maintenance or repair of such property (3) the collection of rents or rental of such property, or (4) the conduct of any business which is carried on upon such premises. Trustee does not warrant, indemnify, defend title nor is it responsible for any environmental damage.

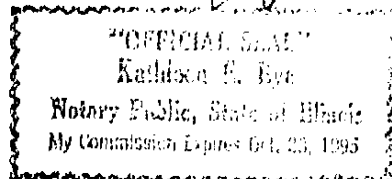

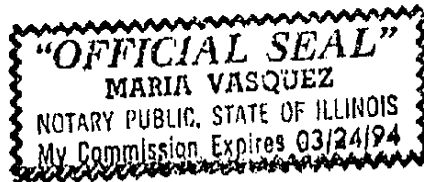
