## EXTENSION AND MODIFICATION AGREEMENT

IT IS FURTHER MUTUALLY AGREED BY AND EFFEEN THE PARTIES THAT ALL PROVISIONS OF said Note and Mortgage shall remain unchanged and in full force and effect for and during said extended period except only as herein specifically modified, and further that in the event of default in the payment of principal or interest due under said Note as herein modified, or in the event of failure to perform any and all of the agreement contained in said Mortgage as herein modified, the entire amount of unpaid principal and interest shall at the option of the holder thereof become imaginately due and payable without notice or demand; that all the rights and obsigations under said Mortgage as modified shall extend to and be binding on the successors and assigns of the parties hereto.
