4. There is now due and owing claimant the sum of \$9,180.00, after allowing to the owner all credits, deductions and set offs, which is still due and unpaid.


5. The claimant now claims a lien on the above described premises and all improvements on it, against all persons interested, for \$9,180.00 dollars, with interest as provided by statute.

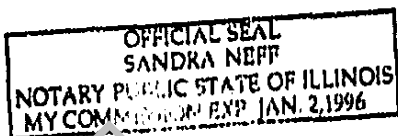
