ASSIGNMENT OF RENTS

GRANTOR'S REPRESENTATIONS AND WARRANTIES WITH RESPECT TO THE RENTS. With respect to the Rents, Grantor represents and warrants to Lander that:

Ownership. Grantor is entitled to receive the Rents free and clear of all rights, loans, liens, encumbrances, and claims except as disclosed to and accepted by Lender in witting.

Right to Assign. Grantor has the full right, power, and authority to enter into this Assignment and to assign and convey the Rents to Lender.

No Prior Acaignment. Grantor has not previously assigned or conveyed the Rents to any other person by any instrument now in force

No Further Transfer. Grantor will not sell, assign, encumber, or otherwise dispose of any of Grantor's rights in the Rents except as provided in this Agreement.

LENDER'S RIGHT TO COLLECT RENTS. Lender shall have the right at any time, and even though no default shall have occurred under this Assignment, to collect and receive the Rents. For this purpose, Lender is hereby given and granted the following rights, powers and authority:

Notice to Tenants, Tender may send notices to any and all tenants of the Property advising them of this Assignment and directing all Rents to be paid directly to Lancer or Lander's agent.

Enter the Property. (enter may enter upon and take possession of the Property, demand, collect and receive from the tenants or from any other persons liable therefor, of the Rents; institute and carry on all legal proceedings necessary for the protection of the Property, including such proceedings as may be lessony to recover possession of the Property; collect this Rents and remove any tenant or tenants or other persons from the Property.

Maintain the Property. Lender my finter upon the Property to maintain the Property and keep the same in repair; to pay the costs thereof and of all services of all employees, including mair equipment, and of all continuing costs and expenses of maintaining the Property in proper repair and condition, and also to pay all texts, assessments and water utilities, and the premiums on fire and other insurance effected by Lender on the

Compliance with Laws. Lender may do any and all things to execute and comply with the laws of the State of Binois and also all other laws, rules, orders, ordinances and requirements of all other governmental agencies affecting the Property.

EXPENDITURES BY LENDER. If such a failure is curable and if Grantor has not been given a notice of a breach of the same provision of this Assignment within the preceding twelve (12) months, it may be cured (and no Event of Default will have occurred) if Grantor, after Lender sends written notice demanding cure of such failure: (a) cures the failure within thirty (30) days; or (b) if the cure requires more than thirty (30) days; immediately initiates steps sufficient to cure the failure and thereafter continues and completes all reasonable and necessary steps sufficient to produce compliance as soon as reasonably practical.

Structures. Any warranty, representation or statement made or furnished to Lender by or on behalf of Grantor under this Assignment, the Note or the Related Documents is, or at the time made or furnished was, talse in any material respect.

Other Defaults. Failure of Grantor to comply with any term, obligation, covenant, or condition contained in any other agreement between Grantor and Lender.

Insolvency. Insecurity. Lander reasonably deems itself insecure.

RIGHTS AND REMEDIES ON DEFAULT. Upon the occurrence of any Event of Default and at any time thereafter, Lender may exercise any one or more of the following rights and remedies, in addition to any other rights or remedies provided by law:

Accelerate Indebtedness. Lender shall have the right at its option without notice to Grantor to declare the entire Indebtedness immediately over and payable, including any prepayment penalty which Grantor would be required to pay.

Collect Rents. Lander shall have the right, without notice to Grantor, to take possession of the Property and collect the Rents, including amounts past due and unpaint, and apply the not proceeds, over and above Lender's costs, against the Indebtedness. In hurther ance of this right, Lender may require any Juna it or other user of the Property to make payments of rent or use fees directly to Lender. If the Rents are collected by Lender, then Grantor intercer's designates Lender as Grantor's attorney-in-fact to endorse instruments received in payment thereof in the name of Grantor and to negular at he same and collect the proceeds. Payments by tenants or other users to Lender in response to Lender's demand shall satisfy the obligations for which the payments are made, whether or not any proper grounds for the demand existed. Lender may exercise its rights under this subpare tenh either in person, by agent, or through a receiver.

Mortgages in Possession. Larrier shall have the right to be placed as mortgages in possession or to have a receiver appointed to take possession of all or any part of the Property, with the power to protect and preserve the Property, to operate the Property preceding foreclosure or cale, and to collect the Reins from the Property and apply the proceeds, over and above the cost of the receivership, against the Indebtedness.
