ORDINANCE #94-18

AN ORDINANCE PERTAINING TO THE ANNEXATION OF CERTAIN TERRITORY INTO THE DOMAIN OF THE PALATINE PARK DISTRICT

WHEREAS, the Palatine Park District is a park district organized and existing under the provisions of the Park District Code approved on May 17, 1951, as amended; and

WHEREAS, Section 3-10 of the Park District Code provides:

"Whenever a Park District operating within territory predominately in a City or Village or two or more Cities or Villages would become co-terminus or nearly co-terminus with such City or Village or two or more Cities or Villages upon the annexation of additional territory within such municipalities but not incorporated within a park district, such park district may annex such additional territory by passage of an Ordinance to that effect," and

WHEREAS, the territory described herein lies within the corporate boundaries of the Village of Palatine, but does not presently lie within the Corporate boundaries of the Palatine Park District; and,

WHEREAS, the Palatine Park District is presently operating within a territory predominately within the corporate limits of the Village of Palatine; and,

WHEREAS, upon the annexation of the territory described herein, the boundaries of the Palatine Park District and the Village of Palatine will become nearly co-terminus;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS of the Palatine Park District, situated in the County of Cook, State of Illinois, that:

Section 1. The territory hereinafter described shall be and it is hereby annexed into the domain of the Palatine Park District.

Section 2. The territory hereby annexed is commonly known as 20-81 N. Middleton, 54 N. Crescent, 16-196 N. Quentin, 801-898 W. Palatine Road, 940-1018 W. Palatine Road in addition to thirty vacant parcels and legally described as follows: Section 2. The territory hereby annexed is commonly known as 1053 W. Palatine Road and legally described as follows:

LOTS 1-5 AND 9 IN BLOCK 8, LOTS 1-4 AND 7-13 IN BLOCK 9, LOTS 1-3 AND 5-12 IN BLOCK 10 AND LOTS 1-5 IN BLOCK 11 LYING EASTERLY OF THE SALT CREEK IN ARTHUR T. MCINTOSH & CO.'S CHICAGO AVENUE FARMS, IN THE SOUTHEAST 1/4 OF SECTION 16, TOWNSHIP

42 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN IN COOK COUNTY, ILLINOIS.

ALSO; THAT PART OF BLOCKS 1 & 2 LYING NORTHERLY OF THE SALT CREEK IN ARTHUR T. MCINTOSH & CO.'S PALATINE HILLS, A SUBDIVISION OF PART OF THE EAST 1/2 OF THE NORTHEAST 1/4 OF SECTION 21, TOWNSHIP 42 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN IN COOK COUNTY, ILLINOIS.

ALSO; THAT PART OF THE NORTH 142 FEET OF THE EAST 433 FEET OF THE EAST 1/2 OF THE NORTHEAST 1/4 OF SECTION 21 LYING NORTHERLY OF THE SALT CREEK IN TOWNSHIP 42 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN IN COOK COUNTY, ILLINOIS.

ALSO; THE NORTH 300 FEET OF THE SOUTH 765.15 FEET OF THE WEST 239.24 FEET OF THE WEST 1/2 OF THE SOUTHWEST 1/4 OF SECTION 15, TOWNSHIP 42 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN IN COOK COUNTY, ILLINOIS.

ALSO, ALL UNINCORPORATED PORTIONS OF QUENTIN ROAD, MIDDLETON AVENUE, WILSON STREET AND CRESCENT AVENUE LYING ADJACENT TO THE ABOVE DESCRIBED PARCELS.

Section 3. The Secretary of the Board is hereby directed to file a certified copy of this Ordinance, together with an accurate map of the annexed territory herein described, in each of the offices of the County Clerk and the County Recorder of the County of Cook, State of Illinois.


