ORDINANCE #94-20

AN ORDINANCE PERTAINING TO THE ANNEXATION OF CERTAIN TERRITORY INTO THE DOMAIN OF THE PALATINE PARK DISTRICT

WHEREAS, the Palatine Park District is a park district organized and existing under the provisions of the Park District Code approved on May 17, 1951, as amended; and

WHEREAS, Section 3-10 of the Park District Code provides:

"Whenever a Park District operating within territory predominately in a City or Village or two or more Cities or Villages would become co-terminus or nearly co-terminus with such City or Village or two or more Cities or Villages upon the annexation of additional territory within such municipalities but not incorporated within a park district, such park district may annex such additional territory by passage of an Ordinance to that effect," and

WHEREAS, the territory described herein lies within the corporate boundaries of the Village of Palatine, but does not presently lie within the Corporate boundaries of the Palatine Park District; and,

WHEREAS, the Palatine Park District is presently operating within a territory predominately within the corporate limits of the Village of Palatine; and,

WHEREAS, upon the annexation of the territory described herein, the boundaries of the Palatine Park District and the Village of Palatine will become nearly co-terminus;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS of the Palatine Park District, situated in the County of Cook, State of Illinois, that:

Section 1. The territory hereinafter described shall be and it is hereby annexed to the domain of the Palatine Park District.

Section 2. The territory hereby annexed is commonly known as the southwest corner of Crescent Avenue and Ellis Street and legally described as follows:

LOT 1 IN BLOCK 15 IN ARTHUR T. MCINTOSH & COMPANY'S PALATINE HILLS, BEING A SUBDIVISION OF PART OF THE EAST HALF OF THE NORTHEAST QUARTER OF SECTION 21, TOWNSHIP 42 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN RECORDED FEBRUARY 15, 1928 AS DOCUMENT NO. 392915 IN COOK COUNTY, ILLINOIS.

ALSO, THAT PORTION OF REDEMPTEE PARCEL RIGHT OF WAY OF ELLIS STREET LYING ADJACENT TO THE ABOVE DESCRIBED PARCEL.




