We will deliver to you upon your request the policies or other proof of the insurance. THIS CONDOMINIUM RIDER is made this TWENTY-FOURTH day of MARCH, 2003 , and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust, or Security Deed (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure Borrower's Note to

Countrywida Bank, a Division of Treasury Bank, N.A.

The Property includes a unit in, together with an undivided interest in the common elements of, a condominium project known as:

(the "Condominium Project"). - C. Public Liability Insurance. Borrower shall take such actions as may be reasonable to insure that the Owners Association maintains a public liability insurance policy acceptable in form, amount, and extent of coverage to Lender.
- D. Condemnation. The proceeds of any award or claim for damages, direct or consequential, payable to Borrower in connection with any condemnation or other taking of all or any part of the Property, whether of the unit or of the common elements, or for any conveyance in lieu of condemnation, are hereby assigned and shall be paid to Lender Sich proceeds shall be applied by Lender to the sums secured by the Security Instrument as provided in Section 1.
- E. Lender's Prio: Consent.
