



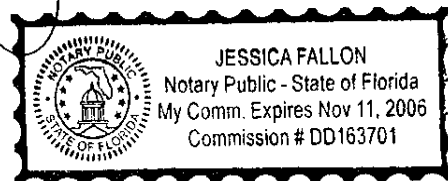

MORTGAGE

THIS MORTGAGE ("Security Instrument") is given on January 6, 1999. The mortgagor is Robert Hall and Patricia Hall, Husband and Wife
