**8. Borrower's Loan Application.** Borrower shall be in default if, during the Loan application process, Borrower or any persons or entities acting at the direction of Borrower or with Borrower's knowledge or consent gave materially false, misleading, or inaccurate information or statements to Lender (or failed to provide Lender with material information) in specifying such reasonable cause.

If it has reasonable cause, Lender may inspect the interior of the improvements on the Property. Lender or his agent may make reasonable entries upon and inspections of the Property. 



This Mortgage Insurance Rider is made this 11th day of April , 2003 , and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust, or Security Deed (the "Security Instrument") of the same date given by the undersigned ("Borrower") to secure Borrower's Fixed Rate note (the "Note") to
