EXHIBIT A

Subject to: current non-delinquent real estate taxes and taxes for subsequent years; applicable zoning, use and building laws or ordinances; Purchaser(s) mortgage; restrictions or conditions of record; and building line agreements.

FENCES: No fence or other non-residential structure shall be erected or maintained on any lot in the Subdivision which shall restrict the view in any way from an adjoining lot in the Subdivision. Fences shall be allowed only in the rear yard of any lot. Said structures shall be no higher than four (4) feet, except for swimming pool enclosures, which in no event shall said fence protrude forward beyond the rear wall of the building, and shall be governed by local ordinances.
