This THIRD AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP FOR 420 W. ONTARIO RESIDENTIAL CONDOMINIUM ASSOCIATION ("Third Amendment") made and entered into on this 28thday of April, 2003, by 420 LOFTS LLC, an Illinois limited liability company, the Second Successor Declarant as provided for below (hereinafter referred to as the "Residential Owner/Developer").

WHEREAS, RESIDENTIAL OWNER/DEVELOPER, as successor by sale to Ontario L.L.C., previously purchased the entire Residential Property from Ontario L.L.C. on November 15, 2001;

WHEREAS, Paragraph 4 of the Second Amendment states:

"Pursuant to Article XIV(d), Second Successor Declarant reserves the right to amend the Declaration at a future date to allocate specific ownership of the limited common areas located on the roof area of the Residential Property."

Wir LEAS, all members of the Second Successor Declarant and Board of Directors of the Condominium have unanimously approved the modifications contained in this Third Amendment to allocate specific ownership of the limited common areas located on the roof area of the Residential Property; and
