**SPECIAL AMENDMENT TO DECLARATION OF
 CONDOMINIUM OWNERSHIP FOR
THE IMPERIAL TOWERS CONDOMINIUM ASSOCIATION**

This is a Special Amendment to Declaration made and executed by the Board of Managers of the Imperial Towers Condominium Association (the "Association") and consented to by Harold B. Eulien, as owner of condominium unit 1B07 in the Association (the "Unit 1B07 Owner").

WITNESSETH

WHEREAS, the real estate described on Exhibit A hereto, located in the County of Cook and State of Illinois ("the "Submitted Parcel") was submitted to the Condominium Property Act of the State of Illinois, as amended (the "Act") pursuant to the Declaration of Condominium Ownership for the Imperial Towers Condominium Association recorded on October 26, 1977 with the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 24165981 (said Declaration, , as amended from time to time, is hereinafter referred to as the "Declaration").

WHEREAS, the dimensions of the condominium units in the Association are described and depicted in the plat of survey attached to the Declaration as Exhibit A, as amended from time to time.

WHEREAS, Section 27(b)(1) of the Act authorizes correction of an omission or other error in a declaration, bylaws, plat of survey or other condominium instruments by an amendment to such declaration, bylaws, plat of survey or other condominium instruments approved by vote of two-thirds of the members of the condominium association's Board of Managers.

WHEREAS, a Fourth Amendment to the Declaration was recorded with the Cook County Recorder of Deeds on May 16, 1994 as Document No. 94437750, which Fourth Amendment purported to sub-divide Commercial Unit 1B into 12 separate condominium units (namely, units 1B01, 1B02 and 1B03 on the 1st Floor, and units 1B04, 1B05, 1B06, 1B07, 1B08, 1B09, 1B10, 1B11 and 1B12 on the 2nd Floor), with each of those twelve units having the dimensions described and depicted on the plat of survey attached to the Fourth Amendment.

WHEREAS, units 1B01, 1B02 and 1B03 and other areas on the 1st Floor of the premises are described and depicted on "Amended Sheet 3 – November 23, 1993 revision" attached to the Fourth Amendment, but, due to a clerical error, the next succeeding survey sheet (namely, "Amended Sheet 4 – November 23, 1993 revision") that described and depicted units 1B04, 1B05, 1B06, 1B07, 1B08, 1B09, 1B10, 1B11 and 1B12 and other areas on the 2nd Floor was inadvertently omitted and not recorded with the Cook County Recorder of Deeds as an attachment to the Fourth Amendment.

WHEREAS, the Board of Managers of the Association wishes to correct said error by recording a survey sheet that describes and depicts units 1B04, 1B05, 1B06, 1B07, 1B08, 1B09, 1B10, 1B11 and 1B12 and other areas on the 2nd Floor in accordance with the "Amended Sheet 4 – November 23, 1993 revision" that should have been attached to and recorded with the Fourth Amendment.

WHEREAS, it also appears that the description and depiction of condominium unit 1B07 on the "Amended Sheet 4 – November 23, 1993 revision" that should have been attached to the Fourth Amendment was in error, in that a small portion of Unit 1B07 was erroneously described and depicted as a part of the common elements of the Association rather than as a part of Unit 1B07.

WHEREAS, the Board of Managers of the Association and the Unit 1B07 Owner both agree that the description and depiction of condominium unit 1B07 on the "Amended Sheet 4 – November 23, 1993 revision" that should have been attached to the Fourth Amendment was in error, and that an accurate and correct description and depiction of condominium unit 1B07 appears on the "Amended Sheet 4 - December 30, 2002 revision" attached hereto as Exhibit B.

WHEREAS, the Board of Managers of the Association and the Unit 1B07 Owner both agree that Sheet 4 of the plat of survey attached to the Declaration as Exhibit A, as amended from time to time, should be replaced with the "Amended Sheet 4 - December 30, 2002 revision" attached hereto as Exhibit B.

WHEREAS, more than two-thirds of the members of the Association's Board of Managers have, at a meeting of the Board of Managers called for such propose, duly voted to correct both of the foregoing errors by replacing Sheet 4 of the plat of survey attached to the Declaration as Exhibit A, as amended from time to time, with the "Amended Sheet 4 - December 30, 2002 revision" attached hereto as Exhibit B

WHEREAS, the Unit 1B07 Owner wishes to consent to replacement of Sheet 4 of the plat of survey attached to the Declaration as Exhibit A, as amended from time to time, with the "Amended Sheet 4 - December 30, 2002 revision" attached hereto as Exhibit B.

NOW, THEREFORE, the Board of Managers of the Association, with the consent and approval of the Unit 1B07 Owner, hereby declares that the Declaration is amended as follows:

1. Sheet 4 of the plat of survey attached to the Declaration as Exhibit A, as amended from time to time, is hereby deleted and replaced with the "Amended Sheet 4 - December 30, 2002 revision" attached hereto as Exhibit B.

2. The Fourth Amendment is hereby amended by the addition of the plat of survey attached hereto as Exhibit B to the plats of survey attached to the Fourth Amendment.

3. Except as expressly modified herein, the Declaration and the plat of survey shall continue in full force and effect, and the percentage ownership interest assigned to Unit 1B07 shall remain unchanged and not be affected in any way by this Amendment




