1. Payment of Principal, Interest and Late Charge. Borrower shall pay when due the principal of, and interest on, the debt evidenced by the Note and late charges due under the Note.

2. Monthly Payment of Taxes, Insurance and Other Charges. Borrower shall include in each monthly payment, together with the principal and interest as set forth in the Note and any late charge, (a) sum for (a) taxes and special assessments levied or to be levied against the Property, (b) leasehold payments or ground rents on the property, and (c) premiums for insurance required under paragraph 4. - (i) All or part of the Property, or a beneficial interest in a trust owning all or part of the Property, is sold or otherwise transferred (other than by devise or descent), and

10. Reinstatement. This right applies even after foreclosure proceedings are instituted. To reinstate the Security Instrument, Borrower shall tender in a lump sum all amounts required to bring Borrower's account current including, to the extent they are obligations of Borrower under this Security Instrument, foreclosure costs and reasonable and customary attorneys' fees and expenses properly associated with the foreclosure proceeding. Upon reinstatement by Borrower, this Security Instrument and the obligations that it secures shall remain in effect as if Lender had not required immediate payment in full. 11. Borrower Not Released; Forbearance By Lender Not a Waiver. 



If the monthly payment amount calculated in accordance with paragraph (E) of this Rider increases in the month following the date of the notice, Lender shall pay the difference between the new monthly payment amount and the old monthly payment amount calculated in accordance with paragraph (E) of this Rider for the month following the date of the notice. The new monthly payment amount will be the amount of the new monthly payment amount plus the difference between the new monthly payment amount and the old monthly payment amount calculated in accordance with paragraph (E) of this Rider.

(G) Effective Date of Changes

The notice of change must be given at least 25 days before the new monthly payment amount is due, and must set forth (i) the date of the notice, (ii) the Change Date, (iii) the old interest rate, (iv) the new interest rate required by law from time to time, calculating the change in monthly payment amount, and (v) any other information which may be required by law from time to time.

If the interest rate changes on a Change Date, Lender will calculate the amount of monthly payment of principal and interest. This calculation will be the amount of the new monthly payment of principal and interest. The result of this calculation will be the amount of any prepayments to principal. The result of no default in payment on the Note, reduced by the amount of any prepayments to principal. Lender will use the unpaid principal balance which would be owed on the Change Date if there had been Matuity Date at the new interest rate through substantially equal payments. In making such calculation, Lender will add interest which would be necessary to repay the unpaid principal balance in full at the date of change. The new interest rate will never increase by more than one percentage point (1.0%) on any single Change Date. The interest rate will never be more than five percentage points (5.0%) higher or lower than the initial interest rate, as stated in Paragraph 2 of the Note.

(E) Calculation of Payment Change

The existing interest rate will never increase or decrease by more than one percentage point (1.0%) on any single Change Date. The interest rate will never increase or decrease by more than one percentage point (0.125%). Subject to the limits stated in paragraph (D) of this Rider, this rounded amount will be the new interest rate until the next Change Date. Before each Change Date, Lender will calculate a new interest rate by adding a margin of 2.750% to the Current Index and rounding the sum to the nearest one-eighth of one percentage point. Before each Change Date, Lender will calculate a new interest rate by adding a margin of 2.750% to the Current Index and rounding the sum to the nearest one-eighth of one percentage point. Subject to the limits stated in paragraph (D) of this Rider, this rounded amount will be the new interest rate until the next Change Date.
