EXHIBIT "A"

LEGAL DESCRIPTION OF CONTINENTAL PLAZA ASSOCIATES PROJECT NO. 071-35465-IL 06-0054-014:

That part of the East 1/2 of the Southwest 1/4 of Section 29, Township 38 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois, described as follows:

Parcel "A": Beginning at a point 33 feet North of and 33 feet East of the South West corner of the North 1/4 ci the East 1/2 of the South West 1/4 of aforementioned Section 29-38-14; thence Northerly along a line parallel with and 33 feet East of said West line of the East 1/2 of the South West 1/4 of Section 29-38-14, a distance of 410.00 feet; thence Easterly along a line parallel with the North line of the Southwest 1/4 of Section 29-38-14, a distance of 629.89 feet; thence Southerly along a line parallel with and 662.89 feet East of the West line of the East 1/2 of the South West 1/4 of said Section 29-38-14, to a point on the North line of West 76th Street, as opened by condemnation; thence Westerly along the North line of West 76th Street, per Doc. #12300011, to the point of beginning.

Parcel "B": Beginning at a point 33 feet South of and 33 feet East of the South West corner of the North 1/4 of the East 1/2 of the South West 1/4 of aforementioned Section 29-38-14; thence Easterly along the South line of West 76th Street, per Doc. \$12300011, to a point 663.39 feet East of the West line of the East 1/2 of the South West 1/4 of Section 29-38-14; thence Southerly along a line parallel with and 663.39 feet East of the West line of the Fast 1/2 of the Southwest 1/4 of Section 29-38-14, a distance of 335.80 feet; thence Westerly along a line parallel with the North line of the Southwest 1/4 of Section 29-38-14, to the point of intersection of said line with the East line of South Loomis Blvd.; thence Northerly along the East line of said South Loomis Blvd. to the point of beginning.
