## RESTRICTIVE COVENANT

This covenant shall run with the land and be binding up in all successors in title, transferees and all other persons having any interest whatsoever in said real estate. This document shall be recorded by the Village in the Office of the Recorder of Deeds, Cook County, Wirosis.
