Each of these dates is called a "Payment Change Date."

(F) Additions to My Unpaid Principal

My monthly payment could be less than the amount of the interest portion of the monthly payment that would be sufficient to repay the unpaid principal I owe at the monthly payment date in full on the Maturity Date in substantially equal payments. For each month that the monthly payment is less than the interest por ion, the Note Holder will subtract the amount of the monthly payment from the amount of the interest portion and will add the difference to my unpaid principal. The Note Holder will add interest on the amount of this difference to my unpaid principal each month for the period of time the additional amounts remain unpaid. The interest rate on the interest added to principal will be the rate required by Section 2 above.

(G) Limit on My Unpaid Principal; Increased Monthly Payment

My unpaid principal can never exceed a maximum amount equal to ONE HUNDRED TEN

percent

(170 %) of the principal amount I originally borrowed. In the event my unpaid principal would otherwise exact that amount, I will begin paying a new monthly payment until the next Payment Change Date without regard to the payment limitation in Section 4(C). The new monthly payment will be in an amount which would be sufficient to repay my then unpaid principal in full on the Maturity Date in substantially equal payments at the interest rate effective the preceding month.

(H) Required Fully Amortazing Monthly Payment

On the fifth a niversary of the due date of my first monthly payment, and on that same day every year thereafter, my monthly payment will be adjusted without regard to the payment limitation in Section 4(C).

(I) Notice of Changes

The Note Holder will deliver or mail to me a notice of any changes in my interest rate and the amount of my monthly payment before the effective date of my change. B. TRANSFER OF THE PROPERTY OR A BENEFICIAL INTEREST IN BORROWER

Transfer of the Property or a Beneficial Interest in Borrower. As used in this Section 18, "Interest in the Property" means any legal or beneficial interest in the Property, including but not limited to, those beneficial interests transferred in a bond for deed, contract for deed, installment sides contract or escrow agreement, the intent of which is the transfer of title by Borrower at a future date to a purchaser. If all or any part of the Property or any Interest in the Property is sold or transferred (or if Borrower is not a natural person and a beneficial interest in Borrower is sold or transferred) without Lender's prior written consent, Lender may require immediate payment in full of all sums secured by this Security Instrument. However, this option shall not be exercised by Lender if such exercise is prohibited by Applicable Law. Lender also shall not exercise this option if: (a) Borrower causes to be submitted to Lender information required by Lender to evaluate the intended transferee as if a new loan were being made to the transferee; and (b) Lender reasonably leter mines that Lender's security will not be impaired by the loan assumption and that the risk of a breach of any coverage or agreement in this Security Instrument is acceptable to Lender.
