## AMENDMENT TO THE DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS, COVENANTS AND BY-LAWS FOR THE ORCHARD VALE CONDOMINIUM ASSOCIATION NO. 1

For Use By The Recorder's Office Only

This document is recorded for the purpose of amending the Declaration of Condominium Ownership and of Easements, Restrictions, Covenants and By-Laws (hereafter the "Declaration") for the Orchard Vale Condominium Association No. 1, (hereafter the "Association"), which Declaration was recorded on May 31, 1979 as Document Number 24383409 in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property") legally described in Exhibit "A," which is attached hereto and made a part hereof.

This Amendment is adopted pursuant to the provisions of Paragraph 13.09 of Article XIII of the aforesaid Declaration. Said section provides that the Declaration may be amended by an instrument in writing signed and acknowledged by the Board, the Owners having at least seventy-five percent (75%) of the total vote and the mortgagees having bona fide liens of record against such Owners' Unit Ownerships. The amendment is effective upon recordation.

### RECITALS

**WHEREAS**, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been subjected to the covenants contained therein; and

**WHEREAS**, the Board and the Owners desire to amend the Declaration in order to provide for the orderly operation of the Property; and

**WHEREAS**, the following Amendment has been approved by the Board, which approval is attached hereto as Exhibit B; and

**WHEREAS**, pursuant to Article XIII, Section 13.08 a copy of said instrument has been mailed to all mortgagees having bona fide liens of record, as evidenced by the affidavit of the Secretary of the Board attached hereto as Exhibit "C". Included in this mailing was a consent form for mortgagees to utilize, in the format attached hereto as Exhibit "D"; and

**WHEREAS**, the consent of mortgagees has been obtained.

**NOW, THEREFORE**, the Declaration of Condominium for the Orchard Vale Condominium Association No. 1 is hereby amended in accordance with the text which follows (Additions in text are indicated by underline; deletions by ~~strike-outs~~):

1. **Article VIII of the Declaration is hereby amended by adding the following paragraphs:**

8.09 Leasing of Units. Notwithstanding any foregoing provisions of this Declaration to the contrary, rental or leasing of Units is prohibited effective with the recording of this Amendment, except as hereinafter provided.

(a) To meet special situations and to avoid undue hardship or practical difficulties, the Board may, but is not required to, grant permission to a Unit Owner to lease his Unit to a specified lessee for a period of not more than one (1) year on such reasonable terms as the Board may establish. Such permission may be granted by the Board only upon written application by the Unit Owner to the Board. The Board shall respond to each application in writing within thirty (30) days of the submission thereof. The Board has sole and complete discretion to approve or disapprove any Unit Owner's application for a lease. The Board's decision shall be final and binding. Any lease approved by the Board shall be subject to the Declaration, By-Laws and rules and regulations governing the Association.

(b) Units that are being leased as of the recording of this Amendment may continue to be leased until the current Unit Owner sells or otherwise transfers the Unit. Once sold or otherwise transferred, the Unit may not be rented.

(c) The restriction on leasing shall not apply to the rental or leasing of units to a blood relative of the Owner, even if a written memorandum or agreement has been executed between the parties. A blood relative is defined as a parent, grandparent, child (natural or adopted) or grandchild of a Unit Owner.

(d) The Board of Directors of the Association shall have the right to lease any Association owned Units or any Unit which the Association has possession, pursuant to any court order, and said Units shall not be subject to this Amendment.

**2. This Amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois.**

**3. Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.**

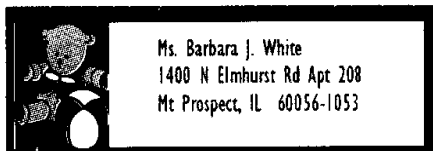
