**AMENDMENT  
TO THE DECLARATION  
OF CONDOMINIUM  
OWNERSHIP AND BY-  
LAWS, EASEMENTS,  
RESTRICTIONS AND  
COVENANTS FOR  
700 GRACELAND  
CONDOMINIUM  
ASSOCIATION**

This Amendment to Declaration is made and entered into the 6 day of MAY, 2003, and is an amendment to that certain Declaration of Condominium Ownership and By-Laws, Easements, Restrictions and Covenants for the 700 Graceland Condominium Association, recorded in the Office of the Recorder of Deeds of Cook County, Illinois as Document Number 86421126 in 1986 ("Declaration").

**WITNESSETH:**

**WHEREAS**, the 700 Graceland Condominium Association (hereinafter referred to as "Association") is the assignee of the developer's rights as set forth and described in the Declaration; and

**WHEREAS**, pursuant to Article XIII, of the Declaration, the Declaration may be amended by an instrument in writing signed and acknowledged by all members of the Board, and certifying that at least 3/4ths of the unit owners have approved the Amendment in writing and containing an affidavit by an officer of the Board certifying that a copy of the amendment has been mailed by certified mail to all mortgagees having bona fide liens of record against any unit not less than 10 days prior to the date of such affidavit; and

**WHEREAS**, said instrument has been signed and acknowledged by all members of the Board, said acknowledgement being attached hereto as Exhibit B; and

**WHEREAS**, said instrument has been approved by at least 3/4ths of the unit owners in writing, as evidenced by the attached certificate by the President of the Association and the ballots/petitions of said owners are attached hereto; and

**WHEREAS**, an affidavit signed by an officer of the Association is attached hereto as Exhibit C certifying that a complete copy of the amendment has been mailed to

all mortgagees having bona fide liens of record against any Unit, not less than ten days prior to the date of such affidavit.

**NOW THEREFORE**, the Association hereby declares that Article XI, Section 1(f) of the Declaration be and is hereby amended as follows (additions in text are indicated by underline, deletions by strike through).

The undersigned, for the purposes set forth, hereby declare that Article XI, Section 1(f) of the Declaration shall be amended to provide the following:

~~(f). No animals of any kind shall be raised, bred, or kept in any Unit or in the common elements, except that dogs, cats, or other household pets may be kept in the Units, subject to the rules and regulations adopted by the Board, provided that they are not kept, bred, or maintained for any commercial purpose; and provided further that any such pet causing or creating a nuisance or unreasonable disturbance shall be permanently removed from the property upon three (3) days' written notice from the Board.~~

(f). Pets, etc. No animals, reptiles, rabbits, livestock, fowl or poultry or any kind shall be raised bred or kept in any unit or in the common elements. Dogs shall not be kept in any unit or in the common elements. Cats or other small household pets may be kept in units, subject to rules and regulations adopted by the Board, provided that they are not kept, bred or maintained for any commercial purpose, and provided further that any such pet causing or creating a nuisance or unreasonable disturbance shall be permanently removed from the property upon three days' written notice from the Board.

This Amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois.

Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.

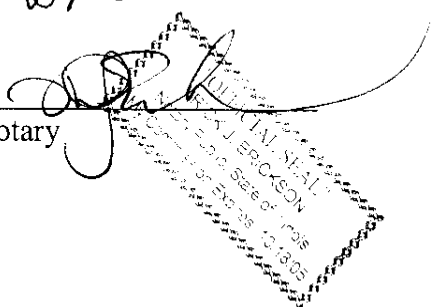
