SUBORDINATION AGREEMENT




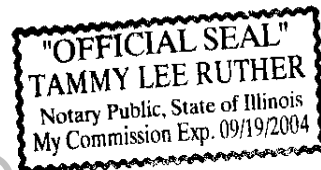
